RESOLUTION TO PROCEED WITH THE PROPOSITION OF A RENEWAL INCOME TAX (Ohio Revised Code Sections 5748.02 and 5748.03)

WHEREAS, the Board at its meeting on January 9, 2023 determined that it is necessary to raise annually additional revenues of at least \$4,689,754 for the purpose of providing for the current operating expenses of the School District; and

WHEREAS, the Tax Commissioner of the State of Ohio has estimated and certified the property tax rate and the income tax rate required in order to produce such additional revenues; and

WHEREAS, the income tax rate, rounded to the nearest one-fourth of one percent as required by law, is 1.00% per annum; and

WHEREAS, such rate is not higher than the income tax approved by the voters of the School District on May 8, 2018 for five years (the "Existing Income Tax");

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Johnstown-Monroe Local School District, Licking and Delaware Counties, Ohio, a majority of all of the members thereof concurring, that:

- $\underline{\text{Section 1}}$ . It is hereby determined to be necessary to proceed with the proposition of levying a renewal of the Existing Income Tax on the school district income of individuals and estates resident in the School District. Such renewal income tax shall be at the rate of 1.00% per annum, shall be for the purpose of providing for the current operating expenses of the School District, shall take effect and begin to be levied on January 1, 2024, and shall be levied for a period of five years (the "Income Tax").
- Section 2. The income that shall be subject to the Income Tax is the taxable income of individuals and estates as defined in Ohio Revised Code Sections 5748.01(E)(1)(a) and (2).
- Section 3. The question of levying the Income Tax shall be submitted to all of the electors of the entire School District at the election to be held at the usual voting places within the School District on May 2, 2023. The entire School District is located in Licking and Delaware Counties, Ohio.
  - Section 4. The form of the ballot to be used at said election shall be as follows:

Shall an annual income tax of one percent (1.00%) on the school district income of individuals and of estates be imposed by the Johnstown-Monroe Local School District to renew an income tax expiring at the end of 2023, for five (5) years, beginning January 1, 2024, for the purpose of providing for the current operating expenses of the School District?

- <u>Section 5</u>. The Treasurer of the School District is hereby directed to certify a copy of this Resolution to the Board of Elections of Licking County, Ohio, not later than February 1, 2023.
- <u>Section 6</u>. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements,

including Ohio Revised Code Section 121.22.

RESOLUTION DECLARING INTENT TO PROCEED
WITH ELECTION ON THE QUESTION OF THE RENEWAL
OF AN EMERGENCY TAX LEVY

(Ohio Revised Code Sections 5705.194 - 5705.197)

WHEREAS, on January 9, 2023, the Board passed a resolution (the "Resolution of Necessity") declaring the necessity, in order to renew all of the existing tax levy, to raise the amount of \$2,200,000 for each year that said levy is in effect, for a period of five years, and upon the entire territory of the School District; and

WHEREAS, the County Auditor of Licking County, Ohio (the "County Auditor") has certified to the Board that an estimated annual levy of 4.8 mills for each \$1 of taxable value, which is \$168.00 for each \$100,000 of the County Auditor's appraised value, will be required to produce the annual amount set forth in the Resolution of Necessity.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Johnstown-Monroe Local School District, Licking and Delaware Counties, Ohio, a majority of all of the members thereof concurring, that:

<u>Section 1</u>. The Board desires to proceed with the submission of the question of such renewal emergency tax levy (the "Emergency Levy") to the electors of the School District.

Section 2. The question of the Emergency Levy shall be submitted to all the electors in the entire territory of the School District at the election to be held on May 2, 2023 (the "Election Date"). All of the territory of the School District is located in Licking and Delaware Counties, Ohio.

### <u>Section 3</u>. The form of the ballot to be used at said election shall be substantially as follows:

Shall a levy renewing an existing levy be imposed by the Johnstown-Monroe Local School District, Licking and Delaware Counties, Ohio for the purpose of providing for the emergency requirements of the School District, in the sum of \$2,200,000 and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average 4.8 mills for each \$1 of taxable value, which amounts to \$168.00 for each \$100,000 of the county auditor's appraised value, for a period of five years?

FOR THE TAX LEVY
AGAINST THE TAX LEVY

Section 4. The Treasurer of the Board is hereby directed and shall certify, not later than February 1, 2023 (which date is not less than 90 days prior to the Election Date), to the Board of Elections of Licking County, Ohio (the "Board of Elections") a copy of the Resolution of Necessity and a copy of this Resolution together with the amount of the average tax levy, expressed in mills for each \$1 of taxable value, as well as in dollars for each \$100,000 county auditor's appraised value, as estimated by the County Auditor.

Section 5. The Treasurer of the Board is hereby directed and shall certify to the Board of Elections that the Emergency Levy will run for a period of five years and that the Emergency Levy will include a levy on the 2024 tax list and duplicate (2025 collection year) if approved by a majority of the electors voting thereon.

Section 6. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
