### 4. Presentation of Prepared Remarks by the Public

Information: A. Public Remarks

Bonnie Nunley - speaking on behalf of LifeWise Steering Committee of Johnstown. Speaking because current policy that would allow LifeWise is being final approved as rescinded. Asked Dr. Wagner to utilize this current policy and allow LifeWise to continue implementation. Asked Board to not approve the recession of policy. Stated they have over 400 signatures of support.

Jerry Brobeck - Resident speaking with love in is heart. Jesus was a disrupter. Society is actively taking God out of school leading to lack of morality. Each Board member stated a pledge under God. School accepted responsibility to honor the pledge just made to honor unto God. Stated vote is a public profession to stand with Jesus or with the world and will be recorded by God.

Gabby Meadows - Immigrant from Germany at age of 13, and the country she came to was freedom but that has changed. Was a bus driver for 30 years. loved her precious cargo. Now children are bombarded with adversity and confusion.

Dea Block - 4 children attend Johnstown in 1988. Believes if LifeWise had been in school, her children would have had a better experience. Kids could be helped with LifeWise .

Jill McDonald - Was disappointed that at last board meeting, board voted to rescind policy. Expressed it is a vote against character and morals. Board has taken the choice away from parents. When schools started years ago it was learning how to read the bible.

Carol Raines - Parents love the schools and want best education to become productive citizens with additional opportunity to learn of God's love. Request for children to grow, learn and thrive with a God enriched LifeWise program.

Kyle Springer - Associate pastor, married with 4 children. Understands the decision before the board and says will affect people for generations to come. At some point, each person will stand before God to account for their life. Allowing LifeWise in school is best decision and encourage Board to allow it.
